

The Dental Council Regulation

on

Sickness Which is Forbidden to be the Member or to be Registered to Practise Dentistry.

B.E. 2538 (1995)

With the agreement of Special Prime Minister Council, the Dental Council upon the powers conferred by Article 23 (4) (B) and Article 27 upon the Dentists Act B.E. 2537 (1994) issued Dental Council Regulation on sickness which is forbidden to be a member of the Dental Council or to be registered to practise dentistry in Thailand.

The member or the registered dental professional who gets the permission to practise dentistry should not be suffered from the following diseases :

1. Alcoholism
2. Filiariasis
3. Narcotism and drug addicts
4. Psychiatrics
5. Leprosy (transmitted period)
6. Tuberculosis (transmitted period)
7. Yaws and other skin diseases which are not accepted by society or public
8. Veneral diseases (secondary stage with skin symtom)
9. Other diseases which are the main obstacle to practise dentistry.

This regulation has been issued in the Royal Government Gazette and validates a day after the date of issue.

The Registration Fee for Being Membership
B.E. 2538

With the agreement of the Special Prime Minister Council , the Dental Council upon the powers conferred by Article 23 (4) (B) and Article 27 upon the Dentists Act B.E. 2537 (1994) issued Dental Council Regulation on the registration fee for being membership and other charges besides those stated at the end of the Dentists Act as follow :

Item 1. Registration fee for being membership	฿ 800 each
Item 2. Charges	
(1) Admission fee for sitting an examination for getting permission to practise dentistry	฿ 2,000 each
(2) Admission fee for sitting an examination for being a board of speciality in various branches of dentistry	฿ 2,000 each
(3) Cost for the certificate of Dental Council member according to the Article 54	฿ 100 each
(4) Cost for temporary certificate of Dental Council member	฿ 100 each
(5) Cost for certificate for ethical consideration for dental practice	฿ 200 each
(6) Cost for translation of license for practising dentistry dentistry	฿ 200 each
(7) Cost for translation of document showing speciality in various branches of dentistry	฿ 200 each
(8) Cost for changing name, surname or adding prefix or suffix	฿ 100 each
(9) Cost for new identification card	฿ 100 each
(10) Cost for certified important documents	฿ 100 each
(11) Cost for printing other requesting documents except (1) to (10)	฿ 50 each
